LETTER TO ALL MEMBERS OF THE ASSOCIATION.

October 21st, 1913.

DEAR OLD GIRLS,

The noble words of Nelson's private diary have gripped many a heart to-day; and it is a good day on which to be writing a message to members of an old and great School. You who have received your sailing orders are "engaging the enemy more closely" than we on the back line. We send you a message of good cheer, and we hope, when our signal is run up, to follow you with equal courage.

It was a very real pleasure to receive on Founder's Day, and at other times during the year, so many of the Old Girls, who helped to build up the School. Those who were here on Founder's Day will, I know, forgive the repetition of part of the Report. The year has been a happy one, singularly free from illness, and marked by good, steady work and satisfactory results, which are recorded on another page. We have made no history; but we have tried to add another year of sound progress to the many years, close upon eighty now, that the Hall has behind it. We are very glad to have sent out some more trim ships into the fighting line: news of these, too, will be found later on.

Our chronicle is a happy one; but there has been a cloud shadowing us during the last months, in the illness of our beloved Hon. Treasurer and Secretary, Rev. C. H. Griffith, whose work for the Hall, for the past twenty-one years, has been as unsparing as it was wise and just. We rejoice with all our hearts that he is so much better, and has been able to come up to the School twice this term. He was sadly missed on Founder's Day. That was a great Day; and few could have been present at the two Services, and at the afternoon gathering, without feeling that we are of those to whom much has been given and of whom much will be required. It seems that when so much work lies everywhere waiting to be done, the members of this School must be foremost in owning and gladly undertaking responsibility; not putting off the thought of our country's sufferings, nor passing by on the other side, but (after thorough study) setting to work with complete devotion, not only or primarily to earn a living, but to lend a hand to England, whether at home or abroad, to uplift, to enlighten, to educate, to train public opinion everywhere. If that is the aim of this School, the design of our Founder prospers indeed.

Subscriptions, due in April of each year, are payable to the Treasurer at St. Mary's Hall.

The Fifth Annual Meeting of the S.M.H.A. was held on Saturday, January 11th, 1913, in the hall of St. John's Institute, Westminster, which was kindly lent by Archdeacon Wilberforce.

The usual business meeting was held first of all. The office of President of the Association being vacant through the death of Miss Potter, Miss Ghey was elected to succeed her as President. After reading a kind message from Miss Elliott, to whom a telegram of greeting was later sent from the meeting, Miss Ghey made three requests of the members of the Association :—

- (1) That notices of business to be brought forward at the winter meeting should be sent in beforehand to the President or Secretary, with a view to simplifying and shortening the necessary business meeting.
- (2) That items of news for the News-Letter should be sent promptly to the Hall.
- (3) That Old Girls, who at any time are looking for posts, should let Miss Ghey know that they are doing so, as she is constantly asked to recommend workers.

Two further suggestions were also put to the meeting and carried :—

- (1) That the names of those who have omitted to pay their subscription to the Association for two years should be printed in the News-Letter.
- (2) That a balance sheet of the Association accounts should be published both in the News-Letter and in the Report.

Owing to the resignation of E. Lovelock and E. Woodgate from the Birrell Memorial Fund Committee, two new members were elected to serve on it :—

Miss Wright, proposed by H. Bagley, seconded by V. Jones.

B. Saunders, proposed by Miss Thornburgh, seconded by Edith Snowdon Smith.

M. Hunt then brought forward a proposal that, as a memorial from Old Girls to Miss Potter, money should be collected to build a Chapel for the Hall. This was discussed, but, dear to all as was the

thought of such a Chapel, it was generally felt that, in view of the present financial position of the Hall, such a project would be unwise.

The House Committee were reported to be trying by every conceivable economy to lift the burden of financial anxiety; and to add to the expenses of up-keep just then or in the next few years would inevitably give a wrong impression of the state of the Hall funds; for no one would think that a proposal to add to the Buildings would be entertained unless the Hall were fully able to face the cost of up-keep, whereas there was anxious need at that juncture of £200 a year more of income, to provide the sadly-wanted working margin.

A proposal that there should be a memorial of some kind was unanimously carried, and the following eight members were elected to serve as a Committee:—

Miss Thornburgh, proposed by Miss Webster, seconded by F. Innes.

Miss Webster, proposed by I. Geary, seconded by W. Watney.

A. Hazledine, proposed by Miss Wright, seconded by Miss Forrest.

M. Hunt, proposed by V. Jones, seconded by A. Hazledine.

Evelyn Snowdon Smith, proposed by Miss Forrest, seconded by D. Short.

During the further discussion as to the form of the memorial a suggestion (proposed by J. Short and seconded by B. Saunders) was put to the meeting: "That a sum of money be collected and given in some form to the Hall, and that a tablet be put up in the Hall to the memory of Miss Potter." This was carried, and the meeting was dissolved, after a hearty vote of thanks had been passed to Archdeacon Wilberforce for the loan of the hall.

At the kind invitation of Rev. F. Thornburgh, on July 30th, at St. Paul's Vicarage, Lisson Grove, London, the following members of the S.M.H.A. Committee met to discuss the date of the Winter Meeting:—Miss M. Hobbins, Miss Thornburgh, Miss Perry, Miss Short.

It was decided that the next meeting should be held on January 10th at St. Paul's Schools, which were kindly offered by Rev. F. Thornburgh.

It was suggested at the meeting that every member of the S.M.H.A. intending to be present, should try to persuade other members (probably her contemporaries) to meet there, and thus the meeting would be larger and more representative.

THE POTTER MEMORIAL FUND.

As the result of the notices sent out to Old Girls the sum of between £20 and £30 has been subscribed to the above fund. This amount can in no way represent the esteem in which Miss Potter was held, but we think that the smallness of it must be accounted for by the fact that about £160 was collected as a testimonial to her to enable her to go abroad for the winter when she resigned her post at the Hall in 1911. We know how grateful she was for that gift and how she appreciated the loving thoughts of those who contributed to it.

The Memorial Fund is still open to any who may wish to subscribe and we hope to enlist the interest of many friends who have not yet been approached, and we trust that the fund may be considerably swelled before the winter meeting in January.

FOUNDER'S DAY, 1913.

Founder's Day was observed on Friday, October 17th, a very beautiful day of clear sunshine. Holy Communion was celebrated at St. Mark's Church at 8 a.m. The Sermon at the 12 o'clock Service was preached by the Ven. Archdeacon Churton, D.D., who took the text, "And kings shall be thy nursing fathers, and their queens thy nursing mothers; and thou shalt know that I am the Lord; for they shall not be ashamed that wait for me." The preacher said that kings and queens were those who *know*, and know in order to rule; to such was promised by God the glorious destiny of being nursing fathers and nursing mothers to the Church of Christ.

To the sorrow of all present, Miss Blanche Elliott was not well enough to be with us; but Lady Elliott was present, to the happiness

Then followed the Headmistress' Report, the Distribution of Prizes, by Major Thornton, Chairman of the Sussex County Council, and speeches by the Chairman, Major Thornton, the Bishop of Chichester, and the Rev. H. V. Elliott. A large number of friends and parents were entertained afterwards at tea and inspected the School.

MISSIONARY NEWS.

Two Sales of Work fall within the scope of this News-Letter. One was held in the Elliott Hall on November 13th, 1912. Besides stalls for needlework, there was a sweet stall (with sweets made by Miss Taylor, Miss Hunt and Nurse), at which the helpers were kept very busy. There were also a number of Competitions, which added greatly to the interest and liveliness of the day. An excellent tea was provided in the Schoolroom by Mrs. Thompson and other willing workers. The Sale (supplemented by Collections and Boxes) brought in the sum of £9 16s. 6d., which was disposed of as follows: For our Indian Orphan, £4; for India (per Mrs. Morris), 10s.; for the C.M.S. (China), £2; for St. Hilda's Mission (Japan) £1. The balance, £2 6s. 6d., was kept for material for work for the next year.

In remembrance of Miss Potter's great love for Missionary work the Missionary interest of the School this year has resulted in the formation of seven groups, each group taking particular interest in a different country. The countries adopted by the groups are India, China, Africa, Japan, Canada, Australia and Palestine. Each group studies the customs and people of its own country, and the work that is being carried on there.

The Annual Missionary Sale of Work was held on October 2nd, when a Flag Display was given by the girls. The proceeds realised £15, exclusive of expenses, and this money, with £1 5s. from Sunday Collections during the year, was distributed in the following way:—S.P.G. (Bishop in S. Tokyo) £1; C.E.Z.M.S. (Miss M. Church, Building Fund) £1; C.I.M. (Miss Churcher belongs to this Mission) £1; C.C.C.S. (Australia and Canada) £2; C.M.S., £7 7s.; for our Orphan Althea, in Katni Murwara, £4.

Many interesting Cycle Letters have been received during the year, from Miss Ashwin, Miss Churcher, Miss Parkinson and the Bishop in South Tokyo. Miss Parkinson writes of the Inspection of the Lahore Schools, and of an interesting holiday spent in Kashmir.

On November 20th, 1912, nearly the whole School went to see the S.P.G. Missionary Exhibition at the Dome, and found the hour kindly allotted to them all too short to see the wonderful curiosities gathered from all parts of the world.

On October 8th, 1913, we had the pleasure of a visit from Maggie Church, who delighted the School by appearing in a beautiful Chinese dress, to talk to them of her work in China. She has written the following paper for the News-Letter:

"One of the greatest joys in returning to the Old Country after some years away is the joining up again of old links, and so it was a special pleasure to visit St. Mary's Hall last week, when, by Miss Ghey's kind invitation, I was able to give a little account of the work in our C.E.Z.M.S. Girls' Boarding School in Kutien, China, to a very responsive audience. It seemed like old times to be at the Hall again, which, in spite of alterations and enlargements, still looked so familiar,

Naturally my thoughts went back to those "gone before," dear Miss Birrell and Miss Potter, to whom we owed so much in the old school days ; though their work here is ended, yet for many of us it seems to be still going on, for the memory of their influence and example, I am sure, helps many of us still. For myself, having now for some years been in charge of a large girls' boarding school in China, I am glad to be able to say how often the remembrance of Miss Birrell's words and teaching has been a very real help in carrying on the work of that school. It was very nice to find the present generation of St. Mary's Hall pupils really interested, and taking a definite share in Missionary Work, and I hope that our school in China is now linked on in a special way with St. Mary's Hall, as the China group in the School has specially chosen one little girl in the Kutien School to remember definitely in prayer.

"The opportunity in China just now is wonderful ; the desire for education is very strong, and just at the present time our Mission schools have a great opportunity, which may pass by all too quickly when the Chinese government schools become more efficient.

"We long to take hold of this opportunity for giving the girls Christian education, and so preparing Christian teachers for their own people, but most of all we want to lead these girls to Christ, that in this time of change and new ideas they may find in Him the strong and only true Foundation. Will not some more from St. Mary's Hall go forward to share in this work and the privilege which God has given to us? I think God only wants us, each one, to be willing to yield to His call, and then whether He calls to work abroad or at home we can go forth without shrinking, for 'When he putteth forth His own sheep He goeth before them,' only let us take care not to miss His call."

CHANGES AT THE HALL.

To the keen regret of all, Miss Edwards, who had been teaching Mathematics and Botany at the Hall for eight years, was obliged for home reasons to leave us at Easter. Her unsparing and accurate work, her devoted interest in her Form and her Dormitory, and her care for the garden, have left a mark on the life of the School which will not be erased.

Miss Mace, B.Sc., has come to us in her stead, and we wish her long and happy work here.

Nurse Dewar, whose firm and kindly rule at the Sanatorium had endeared her to all, has been obliged to leave on account of her health, and Nurse Stansbury has come in her place, with many adventures to relate, as she has been nursing in the English High School in Constantinople.

SCHOOL WORK.

The Snowdon Smith Divinity Papers were set by Rev. Hubert Brooke. The Prize was won by R. Farrow (VIa).

The School Scholarships were held from January to July, 1913, as follows: Elliott Scholarships, H. Thwaites, M. Boodle; Babington Scholarship, R. Farrow; Snowdon Smith Scholarships, M. Dewar, A. Sadgrove; Nellie Jones Scholarship, O. Thwaites. They have now been redistributed thus: Elliott, R. Farrow (Head Girl), A. Sadgrove; Babington, O. Thwaites; Snowdon Smith, J. Newton, D. Rees; Nellie Jones, D. Adkins.

K. Stanley passed the London Intermediate Arts; H. Thwaites passed the Cambridge Higher Local in French, and took a First Class in History, with Distinction in her Special Period; R. Farrow took Second Class Honours in History in the same Examination.

D. Adkins, M. Dewar and J. Newton passed the London Matriculation; D. Ashe took Honours (Class III) in the Oxford Senior Local, and nine girls passed, D. Lilley with Distinction in History.

In Drawing, 45 papers took Honours and 21 passed, out of 70 sent in. W. Banks and M. Segall took Full Certificates. One sheet was Highly Commended, and two Commended in the First Class, at the R.D.S. Exhibition, 1913.

In Music, A. Sadgrove passed the Advanced Grade of the Associated Board Local Centre Examination, and won the Full Certificate. D. Rees, A. Garforth, G. Hensley passed the Intermediate Grade. Ten girls passed in the Higher Division of the Local Schools Examination, and three in the Lower Division, J. Spurrell in both piano and violin.

The Needlework results were very satisfactory. F. Shildrick, A. Oliphant and W. North gained Full Certificates, for Proficiency in all grades. Of 44 garments sent in, nine were marked "Good," 32 "Very Good," and three "Excellent."

Miss Lees' Science Prize was again won by W. Kitchen, and Miss Walters' Music Prize by A. Sadgrove.

The Form Shield was won at Christmas by IIIb, at Easter by Vb, and in July by Vb.

The Drill Brooches were won by: A. Garforth (three terms), Upper School; S. Searight (two terms), Margaret Banks (Lower School).

The Reading Competition was again held in July, Miss Winterbottom once more kindly acting as Judge. The results were: Div. A., no award; Div. B., P. Smith; Div. C., V. Lasbrey. Highly Commended, W. Hamilton; Commended, B. Shildrick.

Lectures have been given at the Hall by Miss Sowter (C.P.A.S.), Miss M. Church, Rev. John Goodchild (S.P.C.K.), and Mr. Garrison of the Royal Colonial Institute.

Miss Sowter lectured on "A Day in the Life of a Factory Girl," and we followed Peek Frean's biscuits from the flour-sack to the motor van. Her account of her work in S. London was greatly appreciated.

Miss Church's lecture dealt with her work in a Chinese School, and was followed with eager attention.

Mr. Goodchild showed us some fine views of Canada, with special reference to the work of the S.P.C.K.

Mr. Garrison, F.R.G.S., took us "Round the World on the King's Highway," and helped us to realise more fully the greatness and dignity of our Empire.
